## 4. First-aid measures

### Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a poison center or doctor/physician if you feel unwell.

### Skin contact

## 5. Fire-fighting measures

### Suitable extinguishing media

Water fog. Alcohol resistant foam. Carbon dioxide (CO<sub>2</sub>). Dry chemical powder, carbon dioxide, sand or earth may be used for small fires only.

## 6. Accidental release measures

<b>Personal precautions, protective equipment and emergency procedures</b>	Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. This material can accumulate static charge which may cause spark and become an ignition source. Avoid spark promoters. These alone may be insufficient to remove static electricity. 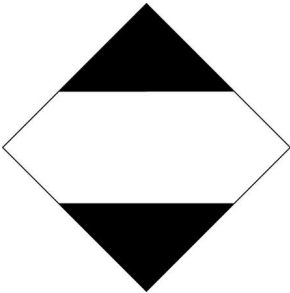

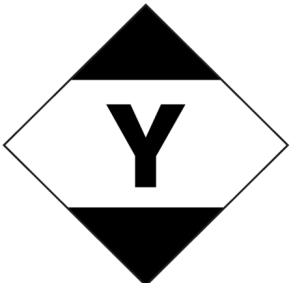
