4. First-aid measures

Inhalation	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell.

6. Accidental release measures

Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. 7. Handling and storage
