Controls and Protection:

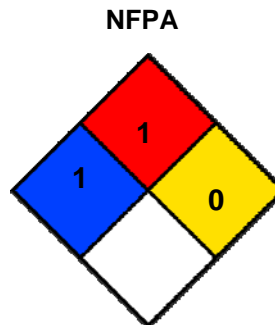
