- Suitable Extinguishing Media: Use extinguishing media appropriate for surrounding fire.

- Explosion Hazards: Aerosol containers, when exposed to heat from fire, may build pressure and explode. Vapors can accumulate and create a flammable atmosphere.

Controls and Protection:

Engineering Controls: Area should have ventilation to provide fresh air. Local exhaust ventilation is generally preferred because it can control the emissions of the contaminant at the source, preventing dispersion into the general work area. 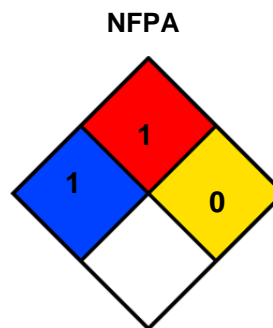
