VI. Directions

- Shake vigorously for at least one minute after rattling of mixing ball is heard. Shake intermittently during application.
- For best results, spray at 50°F to 90°F.
- Surface to be painted should be clean and dry. Remove dirt, grease, oil, rust, scale and other contaminants.
- Mask areas not to be sprayed to protect from overspray.
- Hold can 12 to 16 inches from surface. Press spray button firmly. Do not apply with continuous spray.
 Use back and forth motion, keeping can in a level line with surface.
- For best results 3-4 thin coats are recommended rather than one heavy coat.
- To prevent valve from clogging after spraying, turn can upside down and press sprayhead for about 3 seconds. This will clean paint from siphon tube and valve. If spray button is clogged, remove from can and run knife edge through tiny slit at end of spray button stem. Clear spray button orifice by inserting pin. Do not insert pins or other sharp objects into valve opening of can.
