DIRECTIONS: *Read entire label before using this product.*

Do not apply while equipment is energized. May be harmful to some plastics. Test on small area before using. Remove mechanical plates, covers, etc. to expose equipment interior. Remove heavy deposits of contaminants by scraping or allow degreaser to penetrate 1-3 minutes, then re-apply. Spray until clean. Allow to air dry or dry with absorbent cloth. If necessary, repeat application. Equipment must be completely dry before re-energizing.

ELECTRICAL EQUIPMENT CLEANING: Remove protective cover plates where possible. Remove heavy deposits by scraping. Spray or brush contaminated areas and allow a few minutes to penetrate and loosen grease and oil-related soil. Repeat application until area is clean and dry.

Danger: Combustible liquid. May be fatal if swallowed and enters airways. Causes skin irritation. Causes serious eye irritation. Harmful if inhaled. May cause drowsiness or dizziness.

Precautionary Statements: Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Use with adequate ventilation.
