

CRC Cable Clean® HF™ High Voltage Cable Cleaner

DIRECTIONS: Read entire label before using this product.

1. Do not apply while equipment is energized. 2. Shut-off or disconnect power supply and be sure all stored energy has been drained from the system. 3. For best results, use a mild abrasive before applying Cable Clean®. 4. Spray until clean using an intermittent spray pattern to dislodge contaminants or apply to a lint free cloth and wipe contaminants. 5. If necessary, repeat process until surface is clean. 6. Wipe with a dry lint-free cloth making sure all contaminants have been removed. 7. Allow product to fully evaporate and vent before insulating cables.

1. No aplicar con el equipo con corriente eléctrica. 2. Apague o desconecte la energía eléctrica y asegúrese de que toda la energía almacenada se haya drenado del sistema. 3. Para obtener los mejores resultados, utilice un abrasivo suave antes de aplicar Cable Clean®. 4. Aplique hasta que esté limpio usando un patrón de rociado intermitente para desalojar contaminantes o aplicar a un paño sin pelusa y limpie los contaminantes. 5. Si es necesario, repita el proceso hasta que la superficie esté limpia. 6. Limpie con un paño seco y sin pelusa y asegúrese de que todos los contaminantes han sido eliminados. 7. Permita que el producto se evapore por completo y permita que se ventile antes de aislar los cables.

4. First-aid measures

5. Fire-fighting measures

6. Accidental release measures

Containment and cleaning up Eliminate all ignition sources. Keep combustibles away from spilled material. Absorb in vermiculite, dry sand, earth or other absorbent material and place into containers. Prevent entry into waterways, sewer, basements or confined areas.

Handling Pressurized container. Do not pierce or burn, even after use. When using, do not eat, drink or smoke. Avoid breathing gas, mist or vapor. Avoid contact with skin and eyes. Avoid prolonged exposure. Use only in well-ventilated areas. Wear appropriate personal protective equipment. Wash hands thoroughly after handling.

Storage Store in a cool, dry place (below 122°F/50°C) and out of direct sunlight. Store in a well-ventilated place. Keep away from heat, sparks and open flame. This material can accumulate static charge which may cause spark and become an ignition source.
