HANDLING AND SPILL PRECAUTIONS: Keep container closed. Wash thoroughly after handling. Do not enter where vapors are suspected in high concentration unless air supplied positive pressure breathing apparatus is used and a trained observer is present and equipped with rescue gear. FOR SPILLS, use proper protective equipment. Take precautions as necessary to prevent contamination of ground or surface water. For small spills, use absorbent and sweep into closed containers for disposal. For large spills, evacuate the area, dike and transfer into containers for disposal.

DISPOSAL: Used and unused contents and containers must be disposed of in accordance with all federal, state, and local regulations. EMPTY containers may be offered to a qualified reconditioner. Unused contents may be offered to a licensed reclaimer.

If not breathing, give artificial respiration. If breathing is difficult, give oxygen. For severe overexposure, call a physician immediately.
