

CRC Industrial Adhesive Remover

DIRECTIONS: Read entire label before using this product.

1. Spray CRC Industrial Adhesive Remover on labeled surfaces or surface being cleaned. 2. Wait a few minutes to allow for maximum penetration and loosening action. 3. Use a scraper or wipe with a clean, damp rag. 4. Repeat process and wipe with clean cloth, let air dry. 5. Score surface with blade and repeat application when substance to be removed is too thick for maximum penetration.

INSTRUCCIONES: Lea la etiqueta completa antes de usar este producto.

1. Pulverice el Removedor de Adhesivo Industrial CRC sobre la etiqueta de la superficie o sobre la superficie a limpiarse. 2. Espere algunos minutos para permitir que penetre y desprenda al máximo. 3. Use un raspador o pásale un paño limpio y húmedo. 4. Repita el proceso y páselo un paño limpio; deje que se seque al aire. 5. Raspe la superficie con la lámina y repita la aplicación cuando la sustancia a ser removida sea demasiado espesa para penetración máxima.

4. First-aid measures

Inhalation Remove victim to fresh air and keep at rest in a position comfortable for breathing.

Call a POISON CENTER or doctor/physician if you feel unwell.

Skin contact Remove contaminated clothing. Wash off with soap and plenty of water. If skin irritation occurs: Get medical attention.

Eye contact Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

Ingestion Call a physician or poison control center immediately. Rinse mouth.

Do not induce vomiting. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs.

Most important symptoms/effects Diarrhea. May cause drowsiness, dizziness, headache, nausea and vomiting. Skin irritation. Severe eye irritation. Aspiration may cause pulmonary edema and pneumonitis.

Special treatment needed Provide general supportive measures and treat symptomatically. Keep victim under observation. Symptoms may be delayed.

5. Fire-fighting measures

Suitable extinguishing media Alcohol resistant foam. Water fog. Dry chemical powder. Dry chemicals. Carbon dioxide (CO₂).

Unsuitable extinguishing media None known.

Specific hazards Extremely flammable aerosol. Contents under pressure. Pressurized container may explode when exposed to heat or flame. During fire, gases hazardous to health may be formed.

Special protective equipment and precautions for firefighters Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA.

6. Accidental release measures

Personal precautions Do not touch damaged containers or spilled material unless wearing appropriate protective equipment. Ventilate closed spaces before entering them. Avoid breathing gas, mist or vapor.

Containment and cleaning up Eliminate all ignition sources. Keep combustibles away from spilled material. Wipe up with absorbent material (e.g. cloth, fleece) and place into containers. Prevent entry into waterways, sewer, basements or confined areas.

7. Handling and storage

Handling Pressurized container: Do not pierce or burn, even after use. When using, do not eat, drink or smoke. Avoid breathing gas, mist or vapor. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Use only in well-ventilated areas. Wear appropriate personal protective equipment. Wash hands thoroughly after handling.

Storage Store in a cool, dry place (below 122°F/50°C) and out of direct sunlight. Store in a well-ventilated place. Keep away from heat, sparks and open flame. This material can accumulate static charge which may cause spark and become an ignition source.
