**APPLICATIONS:** Effective and safe for use in all 2 & 4-cycle gasoline engines and all blends of gasoline including gas/oil blends, ethanol-free and ethanol blends up to E85. Not for use in diesel.

**DIRECTIONS:** *Read entire label before using this product.*

Add 1 oz. (30 ml) CRC STOR & GO for every 10 gallons of gasoline at each fill-up for continuous protection. Add 1 oz. to every 5 gallons for maximum protection during storage. To fill measuring chamber simply tilt bottle and fill chamber to desired dose, then pour into fuel. Replace cap. Run engine for 5-10 minutes to allow treated fuel to run through the engine.

**IN-USE: 1 oz. (30 ml) treats 10 Gallons (38L) of fuel**

**STORAGE up to 24 MONTHS: 1 oz. (30 ml) treats 5 Gallons (19L) of fuel**
