**Disc Brake Quiet** is specially formulated to dampen the vibrations that cause disc brake noise. It forms a water-resistant, high temperature film that will absorb noise and quiet disc brake squeal.

**DIRECTIONS:** *Read entire label before using this product.*

**1.** For personal safety, do not apply while equipment is energized. **2.** Remove brake pads and clean with NAPA/CRC Brakleen® Brake Parts Cleaner. **3.** Shake well and spray evenly onto the steel back of each outboard and inboard pad. **4.** Do not apply to lining, rotors, side of pad that contacts rotors, or any moving parts. **5.** Allow to set for 10 minutes and then reassemble brakes. May install while still tacky.
