INGREDIENTS:

Methanol (67-56-1), toluene (108-88-3), acetone (67-64-1), carbon dioxide (124-38-9), dimethoxypropane (77-76-9).

DIRECTIONS:

Remove brake dust using approved techniques. Spray disassembled metal parts liberally. Protect rubber brake parts and painted surfaces from product and over-spray. Do not apply to hot surfaces or energized systems. Repeat if necessary. Allow parts to dry. Re-lubricate required areas with recommended lubricant per Service Manual when parts are re-assembled. Do not spray parts after lubricating - cleaner will remove lubricant. Always test brake system before riding in a normal manner. This product does not meet SCAQMD guidelines for unlimited use.
