**1. Do not apply while equipment is energized.** **2.** Apply liberally on corroded fasteners. **3.** Allow oil to seep between joints and surface area. **4.** Tap joints lightly to aid process. **5.** Loosen or remove fastener. **6.** If necessary, repeat steps 2-4 until fastener breaks free. **7.** Severely frozen or welded fasteners may require the help of a power tool or nut cracker to loosen.
