

DIRECTIONS: Read entire label before using this product. 1. Do not apply while equipment is energized. 2. Clean the weld to be checked with CRC WELD CHECK Weld Cleaner. 3. Shake can of CRC WELD CHECK Penetrant very well and spray a light even coat on the test surface. 4. Allow to remain on the test surface for 10 to 20 minutes. 5. Remove WELD CHECK Penetrant on the test area with a cloth moistened by CRC WELD CHECK Weld Cleaner. 6. Shake can of CRC WELD CHECK Developer very well and spray a light even coat on the test surface. 7. Allow it to spray for 5 to 15 minutes. 8. Inspect the surface for possible defects.

4. First-aid measures

Inhalation Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell.

Skin contact Remove contaminated clothing. Wash off with soap and plenty of water. If skin irritation occurs: Get medical advice.

6. Accidental release measures
