

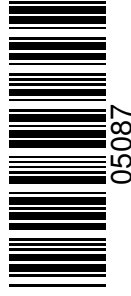

3. Wet down surfaces to be cleaned using short bursts of BRÄKLEEN at a distance of 18-24 inches. Avoid breathing any dust or vapors that may become airborne. (See inhalation warning below)
4. After all surfaces have been wetted, continue spraying BRÄKLEEN to remove contaminants.
5. Air dry or wipe with a clean cloth.
6. For heavy deposits, repeat application as necessary.
7. Runoff should be collected and disposed of properly. (See disposal statement below)

## FIRST AID
