DIRECTIONS: *Read entire label before using this product.*

1. DO NOT apply while equipment is energized or on hot surfaces. 2. Protect all rubber brake parts, plastic parts, rims and painted surfaces from product and overspray. 3. Wet down surfaces to be cleaned using short bursts of BRAKLEEN at a distance of 18-24 inches. Avoid breathing any dust or vapors that may become airborne. (See inhalation warning below) 4. After all surfaces have been wetted, continue spraying BRAKLEEN to remove contaminants. 5. Air dry or wipe with a clean cloth. 6. For heavy deposits, repeat application as necessary. 7. Runoff should be collected and disposed of properly. (See disposal statement below) 8. Professional users should consult SDS and follow all applicable OSHA regulations.
