For cold conditions, use CRC DIESEL FUEL THERAPY with Anti-Gel (No. 05428 / Item# 1003809). For anticipated extreme conditions, add CRC DIESEL Cold Flow™ Anti-Gel with Lubricity (No. 05632 / Item# 1003834) to fuel prior to temperature drop.

Contains petroleum distillates/naphtha 64742-80-9, 64742-47-8, 64742-48-9, and oleic acid 112-80-1.
