DIRECTIONS: Read entire label before using this product.

1. To ensure uniform dispersion, add Bio-Con when tank is half filled. Use entire contents at once. One container treats 50 gallons of diesel fuel. As an initial treatment, use 2 containers to clean the system more rapidly.
2. Once cleaned, one container every third or fourth tankful is sufficient to maintain cleanliness.

Contains diesel fuel 64742-80-9, 2-butoxyethanol 111-76-2, diethylene glycol monomethyl ether 111-77-3, and benzothiazole 21564-17-0. **DANGER:** Avoid breathing vapor and contact with skin and eyes.
