APPLICATIONS: Effective and safe for use in all 2 & 4-cycle gasoline engines and all blends of gasoline including gas/oil blends, ethanol-free and ethanol blends up to E85. Not for use in diesel.

DIRECTIONS: *Read entire label before using this product.*

Add 1 oz (30 mL) CRC STOR & GO for every 10 gallons of gasoline at each fill-up for continuous protection. Add 1 oz to every 5 gallons for maximum protection during storage. To fill measuring chamber simply tilt bottle and fill chamber to desired dose, then pour into fuel. Replace cap. Run engine for 5-10 minutes to allow treated fuel to run through the engine.

IN-USE: 1 oz (30 mL) treats 10 Gallons (38 L) of fuel

STORAGE up to 24 MONTHS: 1 oz (30 mL) treats 5 Gallons (19 L) of fuel

An overdose is not harmful. **CAUTION:** Protect surrounding areas when dispensing product and wipe up any spills immediately to prevent staining. Do not store container above 100°F.

Contains petroleum distillates 64742-47-8, 64742-48-9, 64742-46-7, 64742-94-5, dibutylphenol 128-39-2, and hydrocarbyl amine.

DANGER: Keep away from heat, open flames, and other ignition sources. Do not store container above 100 °F/ 38 °C. Avoid breathing vapors. Do not contact with skin and eyes.
