NAPA/CRC QD<sup>®</sup> Electronic Cleaner is an excellent precision cleaning solvent that cleans and protects sensitive electronic components and contacts. Instantly penetrates hard-to-reach areas to safely dissolve dirt, dust, grease, flux and other contaminants on contact. Evaporates quickly and completely. Regular use helps prevent contact failure and malfunction. Harmless to most plastics and paper tapes.

**DIRECTIONS:** *Read entire label before using this product.*

1. Do not apply while equipment is energized.
2. Spray small amounts on area to be cleaned. Swabs or lint-free cloths may also be used to clean stubborn soils.
3. Allow to dry thoroughly and vent before reactivating. Product may collect and pool in unseen areas. Be certain there are no flammable vapors remaining before reactivation.
4. Note: cleaning may also remove lubrication on moving parts. Relubrication may be necessary.
5. Periodic cleaning may prolong life expectancy of components.

Contains hexanes 107-83-5, 64742-49-0, 110-54-3, 1,1-difluoroethane 75-37-6, and n-pentane 109-66-0.

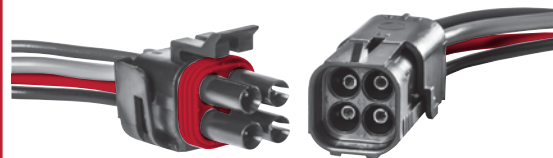
