SUPER CITRUS cleans heavy duty machinery, shop tools, floors as well as walls, restrooms and desks. SUPER CITRUS is extremely effective in dissolving grease, oil, ink, grime and adhesives.

#### Minimum Dilution:

10:1 (Water:HydroForce) for general purpose degreasing

Hard to remove soils or stains may require a higher concentration of Super Citrus™.

#### DIRECTIONS: *Read entire label before using this product.*

Apply appropriate dilution of product to soiled area. May damage some plastic, rubber, and or painted surfaces. Test on an inconspicuous area before general use.
