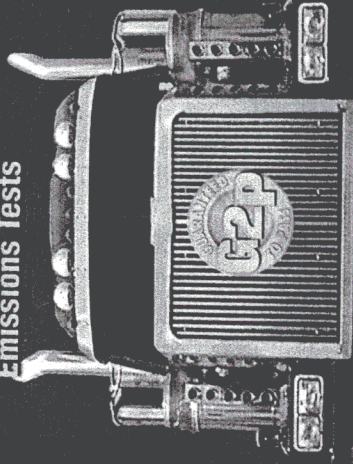

#### Trucks

1. One quart treats 125 gallons of diesel fuel.
2. Pour one quart into each full tank of diesel fuel. Must treat both saddle tanks to pass emissions.
3. Maximum emission reduction is achieved when used 500 to 1000 miles before test is taken.
4. For optimum protection and maintenance use product three times per year.

#### Buses

1. Use 1/2 quart to treat 60 gallons of diesel fuel.

**Caution:** Use of this product in vehicles manufactured prior to 1990 may cause some particulate fuel system clogging due to concentrated detergent action. If clogging occurs, replace fuel filter.
